Annual Report

(FROM 1st APRIL 2023 TO 31st March 2024)

With the support of Paryavaran Evam Proudhyogiki Utthan Samity (PEPUS) and Community is engaged in implementing "INTEGRATED DEVELOPMENT OF BRICK KILN WORKERS AND THEIR FAMILIES" program in Kaudihar block of District Allahabad in Uttar Pradesh.

The Basis of the origination of the society came into the mind of Social Workers while working with the downtrodden and the marginalized communities that the people they were working with are living under pathetic conditions. These communities are trapped under vicious circle of poverty. Also their awareness level was quite low and they considered it as their fate and were totally hopeless for any change in it. These Social Workers believed in the "Establishment of an exploitation free society". For the same Paryavaran Evam Prodyogiki Utthan Samiti (PEPUS) was Established and Registered in 1990 under Societies Registration Act, 1860, having FCRA in the year 1994. PEPUS is regularly striving for building and strengthening capacities of Community Level Institutions like Self Help Groups and Community Based Organizations with participatory approach. PEPUS is also providing its inputs in different ways for strengthening the Migrant Worker community and their left out families. All these efforts have been implemented in rural working areas of total of 170 Gram Panchayats of four Blocks namely Naugarh (Chandauli), Kaudihar (Allahabad), Bihar (Pratapgarh) and Muratganj (Kaushambi) Uttar Pradesh.

PROGRAM OBJECTIVES:-

The key objectives of the organization:

- To get acquainted about the traditions, Socio-Economic conditions of Downtrodden, Underprivileged and labour class people and guiding them towards Sustainable Development.
- To improve and strengthen the Economic Status of target groups through Sustainable Income Generating Programmes along with Skill Development Programmes.
- To motivate Women and Children in School and College going age for enrollment and retention at Education Centres.
- To make aware Peoples Awareness on Health and Environment
- To empower downtrodden and underprivileged Women.

- To provide information regarding Soil texture and Water Conservation along with promoting Sustainable Agriculture.
- To promote Community leadership and Community Participation in Planning, Implementation & Evaluation of Programs.
- Documentation and Publication especially on selected Issues, Establish E Networks of likeminded people and organization.
- To aware community on New Panchayat Raj Act 1993 and Strengthening PRIs.
- Aware Youth and Community with regard to Constitution of India and sensitize on the Preambles of the constitution
- Study, Documentation and information dissemination on Climate Change. Sensitize PRIs, Youth Club, Brick Kiln Association and other Stakeholders for Ecological Development.
- Plan and Implement activities for the welfare and Social Security of Unorganised/Migrant Workers.

STRATEGY:

PEPUS believes in active community participation to bring the community in the main stream through development and building of collectives for sustainability. Keeping above objectives in view the Strategy of the Program has been planned as here under:

QUALITATIVE ACHIEVEMENTS:

Details of Processes and Activities carried out during the Reporting Period

1. Outreach and Community Strengthening through mobilization awareness program (meeting etc.) :

Village Pradhans, Panchayat members and volunteer have extended their cooperation in motivating, mobilizing and facilitating the process of registration, build understanding on Agreements and resolution of disputes. Migrant labourers or Migrant's family members contacted Labour Help Centre (LHC), shared their problems and made queries regarding Registration (BOCW) and IDs during the reporting period. Migrant Laborers got benefit of ID in form of escaping from Police torture during rail journey, Used in making Aadhar cards, Eased in getting work as well as in the voting process.

2. Awareness on Precautions Prior to Migration

Major attention during the tenure of the reporting were on upgrading information and improving sensitivity regarding Precautions before migration (like keeping Identity proof while migrating, Making Agreement before engaging with the job, keeping Labour help line number with them etc) different activities has been carried out during the tenure under reporting. These issues were explained during the Cluster level meetings, istribution of hand bills and small booklets, legal clinic day are different ways through which awareness level has improved among Migrant workers. As a Agreements have been made prior to migration from the inception of the program.. During the awareness meetings and programs, different information regarding services of Labour Help centre and Helpline, MNREGA and BOCW, Registration under BOCW, Ujjvala Scheme, Opening of Saving Bank Account, Prime Minister's Housing scheme, Legal and other Assistance/programs under the project are discussed for ensuring their interest and action towards accessibility. Asha, AWW, Village Pradhan and Members of village Panchayats are participating in village meetings and extending their support in favor of program objectives.

3. Legal clinic Day and Dispute Resolution

During the tenure under reporting 52 clinic days have been organized, Through the legal clinic days held till now the project, 70 cases of unpaid wages due with Brick kiln owners were

registered at LHC. Among 70 cases 45 cases got settled that benefited Rs 4,60,700=00. Senior Legal Council of High Court Allahabad Mr. Jagdish Singh is extending his services as Counsel/Resource Person to facilitate/settle the Legal issues under the program through the Legal clinic days.

4. Financial Inclusion and linkage to social security schemes

As conceived under the project, continuous dialogues have been organized with the Migrant and other families of the project villages towards Economic Literacy, Safe mode of remittance, Habit of small savings and Different social security schemes through the cluster level meetings and in the SVS meetings that can ensure accessibility to migrant workers and their families on social security schemes and change in attitude of saving and remittance through banks.

5. Relationship building and sensitization of stakeholders

Different efforts and initiatives are ensured that can improve the level of social and public accountability among different stake holders. Media, Gram Pradhans, Asha, ANM, Block development office, Labour department office and Health department are contacted to receive their favorable responses towards ensuring rights,(Bocw) welfare and justice to migrant workers and their families. As a result of these processes Gram Pradhans are extending support to Migrant families in getting registered under BOCW. Brick Kiln Owners of the area are also contacted and motivated to create facilities at work sites and ensuring prescribed wages in time. Favorable responses of brick Kiln Owners across the project villages are received at different instances.

6. Self Help Groups (SHG)

Self Help Groups (SHG) have been formed during the reporting period as Group of women from migrant families that can generate Self Employment potential to its members and escape them from private money lending and taking advances from Contractors and the employers. The details of savings and total members under the Self Help Groups (SHG) groups have been furnished at the indicative outputs. However it is worth noting that Private money lending and advances from the employers are root cause of exploitation and promote bondage situations. Few indicative outcomes are as under

- (i) women got functional literacy and have started putting their signatures.
- (ii) women have started Income generation activities with the support of SHG.
- (iii) Fifteen groups have started maintaining Meeting Registers by their own.
- (iv) Fifteen groups have started maintaining pass book and saving records.

7. Labour Help Center (LHC)

Aiming to extend services of counseling against the cases of violations with Migrant labourers, Issuing alternative ID cards, Information Dissemination and collection, legal consultation and help to migrants in crisis, a Labour Help centre has been established at Maheshganj, near under the Kaudihar block of Allahabad. During the reporting period of the program 1491 people from Migrant Families approached for different queries, for getting ID, Legal consultation and help in their problems. Cases has been settled through Labour Help Centre and cases have got settled through Legal Clinic day at Labour Help Centre (LHC).



8. Involvement of Volunteers

Aiming to develop cadre of Volunteers among the migrant families, it was hoped that these Volunteers would extend their cooperation in getting rights of Migrants a ground reality. Shramik Mitras have become active in motivating and educating migrant workers for getting registered under BOCW, Receiving Identity cards and with regards to the services of LHC run by PEPUS.

9. Others Programs (Information dissemination on Climate Change) –

बुनियाद अभियान का प्रमुख उद्देश्य निम्नानुसार है –

1. ईट भट्ठा उद्योगों के सुदृढ़ रूप से संचालित होते रहने की दिशा में भट्ठा मालिकों के एसोसिएशन के साथ सहकार करना |



2. ईट भट्ठों में जिग जैग या अन्य प्रभावी तकनीक जो ईंधन की खपत कम करें और उत्तम गुणवत्ता की अधिकतम ईट का उत्पादन हो सके इसके लिये कोशिश करना
3. ऐसी तकनीको का अनुसन्धान, विकास और प्रसार करना जो ईटों के उत्पादन की लागत को कम करे और प्रदूषण की मात्रा को घटा सके
4. ईट भट्ठों के संचालन में आने वाली दिक्कतों पर चर्चा की जाय और सामूहिक रूप से उसका समाधान की पहल की जाय।

2. पेपुस , 100%UP कोएलेशन, क्लाइमेट एजेंडा, बुनियाद अभियान के संयुक्त तत्वावधान में ईट भट्ठा मालिकों, ईट भट्ठा कामगारों के एसोसिएशन के साथ साथ विभिन्न हितभागियों जिनमें सामाजिक संस्थाओं, ग्राम पंचायतों, संबंधित विभागों, मीडिया आदि के संयुक्त पहल को विकसित कर ईट भट्ठों में सुरक्षित एवं न्यायसंगत कार्य प्रणाली के लिए विभिन्न संदेशों को लेकर प्रेरणा कला मंच के कलाकारों द्वारा मनोहारी नुक्कड़ नाटक का मंचन एवं गीत प्रस्तुत किए गए। प्रयागराज एवं प्रतापगढ़ जिले के कौड़िहार, श्रृंगवेरपुर एवं बिहार ब्लॉक के विभिन्न प्रमुख स्थानों पर नुक्कड़ नाटक का मंचन किया गया। इस कार्यक्रम के माध्यम से हजारों लोगों तक प्रत्यक्ष संदेश "वायुप्रदूषण कम करने में ग्राम पंचायतों एवं समुदाय की भूमिका, ईट भट्ठा मालिकों एवं मजदूर संगठनों की साझी पहल सुनिश्चित कर ईट भट्ठों के स्वच्छ, सुरक्षित एवं न्यायसंगत कार्यप्रणाली से जुड़े संदेशों जिसमें बच्चों की शिक्षा और जेंडर समानता के संदेश और कानून भी शामिल रहे" के लिए कार्यक्रम का आयोजन किया गया।

- (ii) Migrant workers accepting importance of the identity cards and a significant interest have been shown by the migrant's community for getting identity cards.
- (iii) Village Pradhan, NABARD, Media persons and the members of PRIs has begun extending support for engaging Migrant families.
- (iv) Accountability and responses of Health, Development office and Labour department and has been continued.
- (v) Women and Adolescents have started Self employment units.
- (vi) Women from SHG members have started Income Generation Activities through support of SHG groups.
- (vii) Volunteers are supporting to land program dreams at the ground.
- (viii) Migrant families got benefit of different Government schemes from Block development office.

- (ix) Migrant labourers got benefit of BoCW schemes from Labour department.
- (x) Migrant Workers from outside the project villages have begun participating in Legal Clinic days for consultation and resolution of their problems.
